# Eligibility

All Needleart entries must have been made by the living exhibitor with a hand held threaded needle and be appropriately finished. All pictures and wall hangings must be wired for display purposes. Articles entered in last years' exhibit are not eligible. The acceptance committee reserves the right to refuse and/or limit entries that are deemed inappropriate, unable to be properly displayed or adequately secured.

# **Entry Information**

 1) Entries will be accepted at Montpelier Mansion (RTE. 197 & Muirkirk Rd., Laurel, MD) on Sun., July 11 from 2-6 pm & Mon., July 12 from 10 am-12 pm.
2) Junior Amateur entry fees are \$4; all other entry fees are \$5.
3) Each entry must have a separate completed entry form (see last panel) - photocopied forms are acceptable.

4) Insurance coverage is the responsibility of the entrant.

# Judging

Entries will be judged by a panel of regionally known needleart professionals. A list of ribbon recipients will be available on show days at Montpelier Mansion.

# **Classifications for Competition**

#### Divisions

**Professional**: Those who receive payment for design, lecturing, teaching, publishing, or working on needlework. Entries in this division will not be eligible for the Best in Show or Judges' Award.

**Original**: Those works that are truly unique and have been designed by the needleworker. Adult Amateur: Those over 14 years of age who do not receive payment for their needlework. **Junior Amateur**: Those between the ages of 6 and 14 who do not receive payment for their needlework.

#### Techniques

\* Beading (More than 75% of work is beaded)

- \* Needlepoint (continental or tent stitch only)
- \* Counted Canvas (2 or more types of stitch)
- \* Counted Cross Stitch Aida
- \* Counted Cross Stitch -Linen/Evenweave
- \* Samplers (Six or more different stitches on Linen or Evenweave)
- \* Cutwork (Hardanger/Drawn thread)

\* Embroidery (Includes floss, silk, wool, metallic)

- \* Other (tatting, smocking, crochet, knitting, etc.)
- \* Petit-point



Montpelier Mansion, A National Historic Landmark, in Prince George's County, Maryland, is a return to the past, to an era of gracious living & hospitality. Seventy acres and the house itself remain of what once was a plantation with land holdings of approximately 9,000 acres, an array of outbuildings that included various tobacco barns, stables, slave quarters, among others. Large trees and boxwood grace the landscape that also boasts an original 18th century summerhouse. Montpelier Mansion is one of the finest examples of Georgian architecture of the 1700's in Maryland. The Mansion is a property of the Maryland-National Capital Park & Planning Commission and is operated by the Prince George's County, Parks & Recreation Department, Natural and Historical Resources Division.
